Information for your solicitor or financial advisor

If you already have a Will, the wording below will help your legal advisor prepare a codicil to reflect any changes you wish to make. The same wording can be incorporated into your bequest clause if you are writing a Will for the first time.

Residuary bequest (a percentage of the estate residue that transitions into a monetary gift)

I GIVE my residuary estate to my Trustee (s) to divide into XXX (xxx) parts and to hold such parts
UPON TRUST

(c) as to (xx) of such parts to Hamlin Charitable Fistula Hospitals Trust, Charity Registration Number: CC26896 for its general purposes and I DECLARE that the receipt of Hamlin Charitable Fistula Hospitals Trust will be a full discharge to my Trustee(s).

PROVIDED THAT if any part or parts fail then that part or those parts shall be added to the other part or parts that do not fail in the proportions, they bear to each other.

Pecuniary bequest (a specified sum of money)

I GIVE to Hamlin Charitable Fistula Hospitals Trust, Registration Number: CC26896, the sum of \$xxx (AMOUNT IN WORDS) for its general purposes and declare that the receipt of Hamlin Charitable Fistula Hospitals Trust will be a full discharge to my Trustee(s).
